

SPEAKERS



Jimmie L. Harper, DDS, MS

Dr. Harper grew up in Columbus, Ohio and attended Otterbein College, earning his BA degree in Life Sciences in 1976. Dr. Harper received his dental degree from the Ohio State University School of Dentistry in 1979. Upon graduation, he served in the United States Air Force as a restorative dentist for three years at Kirtland AFB in Albuquerque, NM. He returned to the Ohio State University in 1982 to train in Oral & Maxillofacial Surgery, completing his training in 1986. While at Ohio State, Dr. Harper was involved in research and completed the requirements for his Master of Science degree. During his chief year of residency, Dr. Harper received USAF sponsorship and upon graduation, he returned to active duty, serving as Base Oral

& Maxillofacial Surgeon at Carswell AFB in Ft. Worth, TX. Dr. Harper returned to Ohio in 1989 to join Cincinnati Oral & Maxillofacial Surgery, Inc. and currently maintains a private practice in Cincinnati.

Dr. Harper is active in local, state and national organizations. He has served as President of the Cincinnati Dental Society and the Ohio Society of Oral & Maxillofacial Surgeons. He has served as a delegate to American Association of Oral & Maxillofacial Surgeons and the Ohio Dental Association. He is a Diplomate of the American Board of Oral and Maxillofacial Surgery, serving as a Board Examiner in the Section of Medicine/Anesthesia in 2002. He is a fellow of the American Association of Oral and Maxillofacial Surgery. Dr. Harper currently serves as chairman on the American Association of Oral & Maxillofacial Surgeons Committee on Anesthesia and serves as a facilitator in the AAOMS OBEAM simulation course.

Dr. Harper has been actively involved in teaching at the University of Cincinnati since 1990. He served as the Director of Residency Education for the University of Cincinnati Oral & Maxillofacial Surgery Residency Program from 1991 to 1998. He currently serves as Assistant Professor in the Division of Oral & Maxillofacial Surgery, teaching academic courses in Surgical Anatomy and Medicine/Anesthesia Topics for the OMS residents. In addition, he has an appointment with the Division of Plastic and Reconstructive Surgery at Cincinnati Children's Hospital Medical Center.



Michael R. Markiewicz, DDS, MPH, MD

Dr. Markiewicz is Professor and Chair of the Department of Oral and Maxillofacial Surgery at the University of Buffalo, and adjunct Professor in the Departments of Neurosurgery and Surgery at the Jacob's School of Medicine and Biomedical Science. He is an attending Head and Neck and Reconstructive Surgeon and Roswell Park Cancer Center, and is Co-director of the Cleft and Craniofacial Team, at the Craniofacial Center of Western New York. Dr. Markiewicz earned his Dental Degree at the University at Buffalo, and Medical Degree at Oregon Health and Science University where he also completed his General Surgery and Oral and Maxillofacial Surgery training. He obtained a Master's of Public Health from Harvard University

with a concentration in Biostatistics and Epidemiology, and completed a Fellowship in Clinical Investigation at The Massachusetts General Hospital, Boston Massachusetts. Dr. Markiewicz completed a fellowship in Pediatric Cleft and Craniomaxillofacial Surgery, at the Arnold Palmer Hospital for Children, in Orlando Florida. To complete his surgical training, he completed a fellowship in Head and Neck Oncologic and Microvascular Reconstructive Surgery in the Division of Head and Neck Surgery, at the University of Florida, College of Medicine, in Jacksonville Florida. Dr. Markiewicz's clinical and research interests are dedicated to the management of Cleft and Craniofacial anomalies in Children and Adults, the treatment of Head and Neck Cancer, and the reconstruction of Congenital and Acquired Defects in Children and Adults.
